<b>Typical length of the program</b>	Seven terms (1 year and 8 weeks) if full-time taking 2 classes/term (6 units) and the required 81 units were transferred in; program will take longer if student is part-time and/or transfers in fewer than the 81 units.

<b>Cost per term or per course</b>	\$370/unit all inclusive (all books/materials included in online program) (active military \$250/unit) for 2019-2020 undergraduate
<b>Average tuition cost for entire program</b>	\$14,430 (if 81 semester units transferred in and using current tuition rate)
